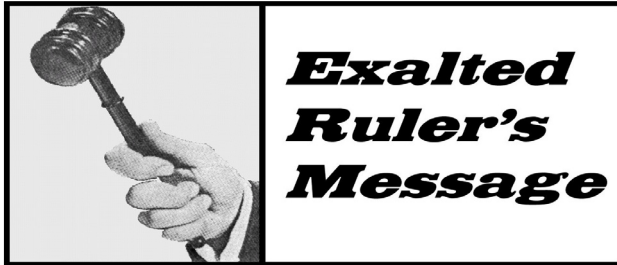

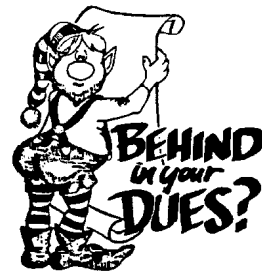

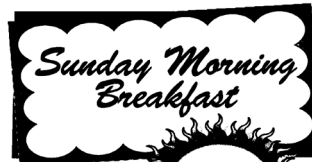

THE OFFICE OF SECRETARY AND TREASURER

When the Lodges of the Northeast District install their Officers, the spotlight is always on the Exalted Ruler. The Chair Officers bask in the glow. However, there are two officers that are always present and stand in the shadows. These two positions are the foundation and the backbone of the Lodge. The men or women who fill these offices are the unsung, overworked brothers and sisters we call "Secretary" and "Treasurer". The Lodges have selected these Ladies and Gentlemen because they are competent persons of character, honesty, and exhibit a proficiency for detail. I cannot overstate the importance of the Secretary and how his or her role affects the success of the Lodge. He or she has been empowered to take and preserve the minutes, maintain records, and handle all the correspondence of the Lodge. If this sounds easy, trust me -- it's not. Minutes must be timely and accurate. Minutes are the recorded history of the Lodge. Statistical record keeping is of paramount importance. It is this type of information that the Grand Lodge requires on a quarterly basis, and the secretary is responsible for submitting the appropriate data in a timely fashion. Correspondence is another time consuming task. The Secretary is obligated to notify the Lodge of Grand Lodge and State Association communications. By the same token he or she is obliged to respond to any of their inquiries. The Secretary that is committed to his or her office, is the brother or sister who keeps the Lodge and its officers organized and on target.

Of equal importance and not to be minimized is the Treasurer. He is the brother or sister we have entrusted to use caution and care in handling the funds of the Lodge. He or she reviews committee reports for accuracy focusing on expenditures versus profits. His or her ledger entries for income and disbursements must be precise and accurate. Based on these computations, the Treasurer is required to file the Lodge's tax return to the IRS. Every year, each Lodge depends on the Treasurer for a thorough financial report. It is from this report that every Lodge projects their budget for the coming year. The Treasurer is the overseer. His or her prime responsibility is to see that the financial structure of the Lodge remains sound.
