Lodge Still Negotiating

Our Lodge is STILL in negotiations with <u>HOLLADAY PROPERTY SERVICES MIDWEST, INC.</u>, 3454 Douglas Road, South Bend, IN, 44635. to sell our property. It is anticipated that at the last Regular Lodge meeting in September, a purchase agreement will be brought to the floor of the Lodge. The terms of the sale will be put forth in a resolution to the floor of the Lodge for a vote by all of the members in good standing as per GL Statutes 16.050.

The written proposal will be read on the Lodge floor at least two but not more than eight weeks prior to the scheduled date for a vote of the Lodge on the proposal setting forth the following applicable information:

- 1. Purpose of project.
- 2. Any amount to be expended.
- 3. Any amount of indebtedness to be created.
- 4. The Person(s) to be authorized to act for the Lodge.
- 5. Amount to be received by the Lodge.

AND— The proposal read on the floor of the Lodge, together with a Notice setting forth the date, time and location of the regular or special meeting at which the proposal will be voted upon, will be provided to each Member of the Lodge in accordance with the provisions of Section 1.115 at <u>least ten (10) days prior to the date of the scheduled meeting.</u> Note that <u>Section 1.115</u> provides that any notice required to be sent or mailed to all Members of a Lodge may be included in the Lodge Bulletin or sent electronically to any Member who has given written authorization to receive notices electronically.

Joliet Elks Lodge #296 would seek to retain the income from the cell towers and the billboards by means of a permanent easement.

Joliet Elks Lodge #296 will retain the proceeds to pay regular expenses while seeking a **temporary** lease location prior to locating a permanent facility. Please attend all Lodge meetings to learn the latest in the negotiations. Also note that the completion of the sale, if approved by all parties would not occur in the immediate future. Discussions will also be ongoing as to where our Lodge should temporarily reside, and what next steps should be undertaken to secure a location.

ENF SCHOLARSHIP OPPORTUNITIES



Applications for the 2025 Legacy Scholarships will open on September 1, 2024. Legacy Awards are \$4,000 scholarships available to children and grandchildren of Elks members. Illinois will have a possibility of 7 Legacy Scholarships. Eligibility requirements are outlined below.

Eligibility:

- For the 2025 contest, any child or grandchild (or step-child, step-grandchild, or legal ward) of a living Elk who joined the Order on or before April 1, 2022, or a charter member of a Lodge that was instituted on or after April 1, 2022, is eligible to apply. The Elk must also be a paid-up member through March 31, 2025. Great-grandchildren are not eligible.
- The applicant must be a high school senior.
- The applicant must apply online only. The 2025 Legacy Awards application deadline is February 3, 2025, 11:59 a.m. Pacific Time. NOTE: This is NOON, mid-day, Pacific time.
- If the applicant's parent and grandparent are both Elk members, the applicant must apply through the parent's Elks Lodge.
- We have waived the standardized test requirement for the 2025 Legacy contest. You do not need to submit ACT and/or SAT scores.
- Students may apply for more than one ENF scholarship; however, they may win only one. In cases where the student wins more than one, we will award the scholarship with the greater value. Students can accept local and state scholarships, which are separate from the awards at the national level.
- Legacy Awards may only be applied to accredited US American schools, colleges or universities. (Note: Applicants from Panama, Puerto Rico and the Philippines may apply Legacy Awards toward schools, colleges or universities in their respective homes.) winners of the 2024 contest in April 2024.
- If you are selected as a 2025 Legacy Awards recipient, you will be required to perform three instances of service with an Elks Lodge during the four years you are receiving the scholarship. Click here for more information about serving with the Elks.

The Elks National Drug Awareness Program strives to teach all children and parents about the dangers of illegal drug use and prevent the abuse of legalized and prescription drugs. As the largest volunteer drug awareness program in the United States, the program relies on state, district and Lodge volunteers to promote a drug-free lifestyle. By taking pride in America's communities and youth, the program takes action against youth drug use through education and inspiration.

Every year, the Elks Drug Awareness Program hands out more than seven million pieces of anti-drug literature to parents, teachers and kids. The brochures are primarily distributed through the program's 90 drug education trailers, which travel to community gatherings, such as fairs and sporting events. The Elks have also teamed with Marvel Comic Books to produce a book featuring Marvel superheroes and Elroy the Elk in a battle against underage drinking. Other educational materials offered by the program include prevention tools for parents, videos, coloring books, posters and public service announcements. Click the banner for more information.

The <u>Illinois Elks Children's Care Corporation</u> generates direct assistance to physically challenged children and scholarship assistance to physical/occupational therapy students in Illinois.

Over 75 years ago, the Elks of Illinois recognized the special needs of physically challenged children. During the early years, much of the work consisted of helping children injured in accidents and suffering from the dreaded disease polio. As times progressed and medical treatments developed for many children's diseases, the focus of the program has evolved to meet new needs and challenges. One constant always remained the guiding question, "What can we do to help this child?"

Many cases are very complex and require custom designed braces, wheelchairs and treatment programs. Others may simply be the provision of corrective shoes or physical/occupational therapy services for three to six months. In all cases, the IECCC works to make certain that appropriate insurance and state benefits are applied before they provide assistance. In this manner, they stretch their available dollars to help as many children as possible.

Conversely, where no insurance or government benefits are available, they will provide assistance in the cost of treatment as needed. Many times they help parents pay the high deductible of their health insurance. They also help with continued treatments costs which can overwhelm a family's budget. On many occasions the IECCC has been told that they've helped when no one else seemed to care.
